


Additionally, we have a strong expertise in delivering in-house development projects where we act as the Developer in bringing projects to fruition. This begins with land acquisition through to completion including funding.






# Graduate Program

Our SQE representatives consult with site teams at least monthly, where they review, assist, guide, and mentor in modern safe work practices to ensure that we are consistently attaining high standards.






## Quality

## 'Galkangu' Bendigo GovHub

The Bendigo GovHub, known as 'Galkangu' is a hybrid structure integrating structural concrete and Glue Laminated Timber (GLT) columns and beams. Meanwhile, locally sourced Cross Laminated Timber (CLT) has been employed for the floor plates.

The project's unique custom mass timber design pushed construction boundaries, and required significant fire testing procedure to meet strict permit requirements, showcasing a commitment to safety, innovation and compliance.

Built with significant design input from traditional owners, Galkangu is noteworthy for its innovative use of sustainable materials, and environmental benefits, including a 6-star Green Star Rating and 6-star NABERS rating.

Distinguished by its dramatic features, the UTAS River's Edge facility was built within tight constraints between existing buildings and the local flood levy, requiring meticulous management and planning.

The project includes cutting-edge building systems and services with state-of-the-art interactive teaching technology that has been seamlessly integrated into architectural finishes.

A significant feature of the internals is the use of local timber, including the pioneering use of Blue Gum timber over a heated slab, creating a success story for this building that will be repeated in future projects.

A commitment to sustainability saw the remarkable achievement of 32.5% reduction in embodied carbon compared to a conventional build of this magnitude.

## **Deakin University - Hycel**

Situated at Deakin University's Warrnambool Campus, Hycel is a groundbreaking research facility dedicated to advancing hydrogen fuel cell development, testing, and manufacture.

The 2,100m<sup>2</sup> facility features five laboratories, and a spacious, enclosed research loading bay capable of accommodating large transport vehicles for testing.

Sustainably designed and constructed with 'green' concrete mix, the project sought to meet strict sustainability requirements, including 95% of steel being sourced through sustainable measures, and 90% of site waste being diverted away from landfill.

An advanced fire detection safety system has been implemented to ensure ongoing safety measures.




## **Devonport Waterfront Hotel**

Impacted heavily by the COVID-19 pandemic, this project forms a significant part of Devonport's 'Living City' urban renewal initiative.

Featuring a 187-room hotel, restaurant, back of house office space, and meeting rooms, the Waterfront Hotel, now operating under the Novotel banner, was initially intended to have two levels of residential apartments before becoming accommodation levels, requiring significant redesign of structural elements that resulted in a 650mm level 1 transfer slab that terminates almost 9m above ground.

Internally, 173 of the 187 hotel rooms feature prefabricated bathroom module pods manufactured in New South Wales and arriving on site requiring only the connection of services, increasing build efficiency.



The largest mass timber construction in Tasmania, St Lukes sets a new benchmark for sustainability in commercial construction.

Fairbrother's expertise in mass timber construction was the driving force behind the flawless execution of he innovative design. At seven storeys in height and a floor area over 7,500m2 the building createas a stunning and sustianable office space.


The building features both gluelaminated timber and cross-laminated timber, and demonstrated exceptional levels of efficiency with the mass timber component delivering a new floor approximately every 10 days.


Integrated sublimely with the existing heritage street frontage, St Lukes demonstrates the excellence and skill Fairbrother can offer in sustainable, mass timber construction.


Fairbrother is more than a construction contractor. Established as a Carpentry and Joinery business, we have stayed true to our roots and seen the continual growth of our internal joinery division.
